- C. Council President Stokes would like to ask the owner of DeConna Ice Cream to do a Solar Presentation for the Town of Reddick.
- D. There have been several concerns about the Owner of the Auto Repair & Dealership located at 15015 NW Gainesville Road (25A), Reddick, FL 32686. The Marion County property records shows Susan M, Kimak as the current owner. They have cut several trees, including the extremely old oaks and they may be filling in the sink hole located on the property near the trees to expand the parking lot. It has been established in the past that this sink hole cannot be filled in. It currently and in the past has been utilized as run off during the torrential rain storms and hurricanes to prevent flooding. It has been heard that he has said that, "He doesn't have to ask the town's permission to do whatever he wants to do on his property". There has been flooding there in the past. It has been suggested that another survey be done before he cuts down the 200-hundred-year-old trees that are not on his property. There were plans in the past to put a Jiffy Store there, but those plans were not approved because of the traffic that it would bring to the school and school cross walk section. He had bulldozers on site yesterday, Tuesday (12/03/2025) clearing the area.
- **E**. Ms. Lucie Ward and one of the girls put up the lovely Christmas Tree before Thanksgiving. They will be adding more Christmas décor this month.

- H. She will also maintain about a week of banked hours to cover any unforeseeable sicknesses, appointments, etc. Also, if the Clerk has to change the normal schedule, does she need to post it on the doors only or should she also email the changes to the Council?
- I. Does the Town send out Christmas Cards to any Vendors, Supplier, Etc. If they have not in the past would they like to? And if so to whom?
- J. Does the Town give out any Christmas Bonuses to any of its local Vendors, such as Florence Williams (she cleans the office) or Michael Henderson (he does the maintenance on the right of ways). If they have not in the past would they like to this year? If so, to whom and how much?
- **K**. Don't forget the Reinder Romp at the Library, December 20th this year. We have provided the donation that was voted on in September in the amount of \$525.00 and will still be providing water and chips as we have done in the past.
